Scotland's smacking ban is due to come into force in just three months, on 7th November 2020.

In this regard, obviously families and various institutions – police, prosecutors, courts and social services – will require time to prepare for the change.

What has the Scottish Government done so far this year to prepare for implementation of the smacking ban?

In particular, what has the Scottish Government done to raise awareness of the criminal consequences for parents who continue to use reasonable chastisement?

You will appreciate that a parent being convicted for something that is considered in many quarters as loving discipline could have serious implications in the life of a family.

Furthermore, if a parent is investigated for smacking their child and was not aware that smacking had been criminalised what does the Government recommend should happen to that parent?

With police and social services overburdened by the coronavirus crisis, how does the Scottish Government expect them to enforce the smacking ban?

Finally, I would strongly advise you to follow the lead of Wales by not implementing the ban until 2022. This would give more time to prepare for its implementation.

What has the Scottish Government done so far this year to raise awareness of the criminal consequences that parents will face? I am not personally aware of any efforts to inform the public, there has been no awareness campaign as far as I can see and I have heard nothing at all, in the media or by post, since the Bill was passed?

There is not even any information on the Parents Club website and even if there were many parents do not use that.

What has the Scottish Government done so far this year to prepare for the implementation of the reasonable chastisement ban?

Many parents are going to find themselves on the wrong side of the law and will face criminal investigation as a result. What action do the Scottish Government recommend for such parents if as the case may well be, they were unaware of the changes to the law?

The police and social services are under immense pressure with the Corona Virus crisis which is likely to continue for the foreseeable future. Can you explain what has been done by the Scottish Government to assist them with implementation of the reasonable chastisement ban? Have they received training on how to deal with situations? Are they in a position to enforce the new law, have they received extra funding to cope with changes?

Dear Minister,

We write, as organisations integral to the successful campaign which brought about the Children (Equal Protection from Assault) (Scotland) Act, to express our disappointment at the recent public messaging on the subject of the imminent legal change, and to offer our support in developing future communications.

Ensuring children are equally protected from assault in the law is a fundamental issue of children's rights. As such, we were delighted with the Scottish Government's strong and unwavering commitment to the Act as it passed through the Scottish Parliament last year. Nevertheless, communicating this legal change to the public is far from straightforward.

The debate surrounding a child's right to equal protection is emotive and nuanced. Throughout the passage of the Bill, supporters, including the Scottish Government, sought to eschew hyperbole and reassure that legal reform is a progressive change, designed to support children and families. Indeed, it was the central strategy of the campaign for equal protection to move beyond the hitherto simplistic debate on 'smacking', which too often became mired in the false dichotomy of parents' rights v children's rights, and unevidenced and alarmist claims about the increased criminalisation parents.

We were therefore dismayed to read the Scottish Government briefing on legal change published last week <u>https://www.gov.scot/publications/physical-punishment-and-discipline-of-children-how-the-law-is-changing/</u> the tone of which was, in our opinion, deeply unhelpful. In particular, the 'dial 999' message (which we are aware has subsequently been amended) led the media to focus on assertions by a pressure group that parents will indeed be subject to increased criminalisation by the new legislation. It is unfortunate to say the least that such headlines have typified the Scottish Government's first public communications on the Act.

It is imperative that the Scottish Government takes the lead in supporting parents and the public to understand legal change as a positive development which can improve family relationships and wider society. Sensitive, nuanced communication around supporting parents and responding to incidents could not be more important, at a time when pressures and uncertainties facing families are arguably unparalleled in modern history.

Countries across the world are looking to Scotland to be an exemplar in implementing legal change to give children equal protection. As organisations with expertise in working with children and families, and passionate about ensuring children are protected from all forms of violence, we would



be happy to offer the Scottish Government any support necessary to ensure the Act is implemented effectively and leads to the shift in attitudes and behaviours that we all desire to make Scotland the best place to grow up.
